In the reference 1<sup>st</sup> cited, Government has accorded permission for Electronic Pension Payment Orders (ePPOs) instead of Physical PPOs through data porting from Accountant General, Telangana to IFMIS and dispensing the physical handling of PPOs. Accordingly, the ePPO was successfully launched and implemented in the District Treasury Offices and APPO offices between the authorizing agency i.e., AG, TG and Disbursing offices (DTOs/JDPPO).

**2.** A meeting was held on 24<sup>th</sup> April, 2026 under the Chair of the Hon'ble Comptroller and Auditor General of India, in the Accountant General Office Complex, Hyderabad. In the meeting the Finance Department and Agriculture & Co-operation Departments along with their HODs have been selected as pilot Departments for implementation of streamlined and integrated online processing of pension proposals/retirement benefits.

**3.** Government, hereby accord permission for implementation of the e-Pension System through IFMIS on a pilot basis in place of the existing manual process for the Finance Department and Agriculture & Cooperation Department along with HoDs under their control. The pension proposals submitted online by pensioners through their respective IFMIS login credentials shall be processed and forwarded by the concerned PSAs through the IFMIS portal. The detailed procedure for online routing of proposals is available on the IFMIS portal.

**4.** All the Pension Sanctioning Authorities and DDO's in Finance Department and Agriculture & Cooperation Department along with HoDs under their control shall henceforth forward the pension proposals through the IFMIS portal, for implementation of the e-pension system on pilot basis.
